## Frequently Asked Questions (FAQs)

### **May CMS add new preventive services as Medicare benefits?**

CMS may add coverage of “additional preventive services” through the National Coverage Determination (NCD) process if the service meets all of the following criteria. The service must be: 1) reasonable and necessary for the prevention or early detection of illness or disability; 2) recommended with a grade of A or B by the United States Preventive Services Task Force (USPSTF); and 3) appropriate for individuals entitled to benefits under Part A or enrolled under Part B of the Medicare Program. ### **What is a primary care setting?**

A primary care setting is defined as one in which there is a provision of integrated, accessible health care services by clinicians who are accountable for addressing a large majority of personal health care needs, developing a sustained partnership with patients, and practicing in the context of family and community. Emergency departments, inpatient hospital settings, ambulatory surgical centers, independent diagnostic testing facilities, skilled nursing facilities, inpatient rehabilitation facilities, and hospices are not considered primary care settings under this definition.


### **How do I determine the last date a beneficiary got a preventive service so I know the beneficiary is eligible to get the next service and the service will not be denied due to frequency edits?**

You have different options for accessing eligibility information depending on the Medicare Administrative Contractor (MAC) jurisdiction where your practice or facility is located. You may be able to access the information through the HIPAA Eligibility Transaction System (HETS) or through the provider call center Interactive Voice Responses (IVRs). CMS suggests that providers check with their MAC to see what options are available to check beneficiary eligibility. ### **My patients do not follow up on routine preventive care. How can I help them remember when they are due for their next preventive service?**
